

## **Hout Bay Near Cape Town**

- More than 13,000 homes about 50,000 people
- Surrounded by mountains and Southern Atlantic Ocean
- Distinct area within wider Cape Town.
- Former fishing village.
- Village atmosphere.
- Settlements: Imizamu Yethu, Hangberg (Township), Wealthy white owned housing







## **Imizamo Yethu – Informal Settlement**

- Partly informal settlement
- 18 ha at high density
- Competition for resources
- Acute housing shortage
- High level of unemployment;
- Health issues
- Political tensions
- Disconnected from wealthy whites and coloured township (Hangberg)



IY and Hout Bay valley, have roughly the same population, 15538 vs. 17329. (City of Cape Town Census 2011)



## Hangberg - Township

- High level of unemployment
- Health issues
- Drug abuse
- Poaching
- Conflict over evictions and clearance of unauthorised structures.



# Who Builds The (Healthy) City?












